A late fee payment fee of 1.5% per month (18% per year) or a minimum of \$5.00 shall be applied to past due amounts. We may terminate service if your account is past due. In the event that Snider Energy (Snider) files a lawsuit to enforce provisions of this agreement, I agree to pay Snider's reasonable attorney and legal fees, to the extent permitted by law. I agree to pay reasonable attorney's fees and costs incurred by Snider in the collection of any amounts which I fail to pay when due. This agreement shall be interpreted and governed by the laws of the State of Washington and in the event of litigation then venue shall be in Pierce County, Washington.
